





Weight Assessment & Counseling for Nutrition & Physical Activity for Children/Adolescents




Percentage of patients 3–17 years of age who had body mass index percentile, and counseling for nutrition and physical activity documentation.

#### Tobacco Use: Screening and Cessation Intervention




Percentage of patients who were screened for tobacco use and received tobacco cessation intervention if identified as a tobacco user.

Since 2017, Wabash Valley Health Center has been Awarded recognition by the National Committee for Quality Assurance (NCQA) Patient-Centered Medical Home (PCMH) program. The PCMH Standards emphasize the use of systematic patient-centered, coordinated care that supports access, communication, and patient involvement.

Exceptional patient satisfaction results: 99.8% of surveyed patients would recommend WVHC to a friend or family member.

WVHC now has a certified SHIP (State Health Insurance Assistance Program) counselor. Achieved full compliance with Health Resources and Services Administration (HRSA) survey program requirements.




